STANDARDIKOMISJONI KOOSOLEK

21 04 95 toimus Standardiameti standardikomisjoni koosolek. Komisjonile esitati läbivaatamiseks järgmised

Eesti standardite koostamissetepanekud:

- 1 Energia kvaliteet
- 2 Nõuded 0,4 kV jaotuspaneelidele
- 3 Tuleohutus. Mänguasjad. Süttivuse ja tule leviku määramine
- 4 Tuletõrjehüdrant
- 5 Informatsiooni edastamiseks kasutatav 7-bitine kodeeritud märgistik
- 6 Keskkond. Vee kvaliteet. Keemiline analüüs
- 7 Piim. Bakterite arvu määramine kasvatamisega temperatuuril 21°C
- 8 Piim ja piimatooted. Pärm- ja hallitusseente arvuline määramine
- 9 Tehnospetsifikaatide koostamine
- 10 Infotehnoloogia terminoloogia, I standardimisjärk (hõlmab 9 standardit)



Komisjonile esitati järgmiste

Eesti standardite lõppredaktsioonid:

- 1 Plastmaterjalid ja plasttooted kasutamiseks kontaktis toiduainetega
- 2 Katselaborite tegevuse üldkriteeriumid
- 3 Katselaborite hindamise üldkriteeriumid
- 4 Üldkriteeriumid laborite akrediteerimisorganitele
- 5 Üldkriteeriumid personali sertifitseerimisega tegelevatele sertifitseerimisorganitele
- 6 Üldküsimumused kvaliteedisüsteemi sertifitseerimisega tegelevatele sertifitseerimisorganitele
- 7 Üldkriteeriumid toote sertifitseerimisega tegelevatele sertifitseerimisorganitele

Komisjon kiitis heaks kõik esitatud Eesti standardite koostamissetepanekud.

Kiideti heaks ka esitatud standardite lõppredaktsioonid va "Plastmaterjalid ja plasttooted kasutamiseks kontaktis toiduainetega". Viimatinimetatut ei kiidetud heaks, kuna direktiivis käsitletud normid on kavas Eesti Toiduseaduse järgi Eestis kehtestada käesoleva aasta lõpuks. Kavand soovitati välja anda Toiduainetööstuse Liidu infomaterjalina.

EUROOPA ÜHISTURG- STANDARDIMINE JA VASTAVUSHINDAMINE

PRAQ92 programmi ekspert Henk W. Huigen

Järgnevalt refereerime PRAQ92 eksperdi Henk W. Huigeni poolt ministeeriumide, ametite, inspeksioonide ja tegevusalauhenduste nn standardimisala võtmeisikutele peetud loengut. (Ekspertide külaskäigu kohta vt ka eelmisest Teataja numbrist)

Eurooliitika avatud Euroopa siseturu saavutamiseks

1985 aasta mais otsustas Euroopa Ühenduse Ministrite Nõukogu vastu võtta EÜ Komisjoni ettepaneku tehnilise harmoniseerimise ja standardimispoliitika osas (COM (85) 19 final 31). Seda dokumenti tuntakse nimetuse all "The New Approach" (Uus lähenemisviis), mis koostati et:

1. parandada Euroopa tööstuse konkurentsivõimet

2. kaotada kaubanduse tehnilised tõkked Euroopa turul

New Approach'i aluseks on 4 põhiprintsiipi:

- Seadusandlik harmoniseerimine piirdub oluliste ohutusnõuetega (EMÜ Lepingu artikli 100a põhimõtete kohaselt välja antud direktiivide kaudu) või teiste üldiste nõuetega, millele tooted peavad vastama EL turul.
- Vajalikke harmoniseeritud standardeid koostavad standardiseerimises kompetentsed organisatsioonid.
- Need nn "harmoniseeritud standardid" ei ole kohustuslikud, nad säilitavad oma vabatahtlike standardite staatuse.
- Riigi võimuorganitel tuleb harmoniseeritud standardite järgi valmistatud tooted tunnistada vastavateks õigusaktidega kehtestatud ohutusnõuetele.

Kui Euroopa Ühenduse direktiiv on enamuse EL liikmesriikide

heakskiitmisel vastu võetud ja selles on kokku lepitud teatavate ohutusnõuete osas, peavad liikmesriigid oma seadusandluse viima vastavusse direktiivi nõuetega.

Neljas põhiprintsiip näitab, et Euroopa standardimispoliitika osana on tehniliste tõkete kaotamine põhimõtte "üldviide standardile" abil.

Niisiis 1985/86 olid juba selgelt äratuntavad New Approach kasutuselevõtu põhiprintsiibid - viies seega lõpule avatud Euroopa turu moodustumise halduse, standardimise, sertifitseerimise ja katsetuste alal.

Seejuures täidavad

- EL ja EFTA haldusfunktsioone
 - CEN, CENELEC ja ETSI standardimisfunktsioone
 - EOTC sertifitseerimisfunktsioone
- EL liikmesriigid on kohustatud viima oma seadusandluse vastavusse EL direktiividega. CEN ja CENELEC liikmesriigid on selle otsuse vastu võtnud kohustudes ühtlasi EN-i kasutusele võtma oma rahvusstandardina ja kõrvaldama käibelt kõik sellega vastuolus olevad standardid. Selline direktiivide ja EN-ide kombinatsioon on võimas vahend teise peamise eesmärgi saavutamisel s.o tehniliste tõkete kõrvaldamisel.

Uue lähenemisviisiga haaratud peamised valdkonnad

on surveanumad, masinad (nende ohutus), gaasiseadmed, mänguasjad (nende ohutus), isikukaitsevahendid, meditsiiniseadmed, telekommunikat-

siooniseadmed, ehitustooted, kaalud, elektromagnetiline sobivus (vt ka direktiivide loetelu käesolevas Teatajas)

Vastavushindamine ja vastastikune tunnustamine

Tehniliste tökete tekkimine Euroopa Liidus ei ole tingitud ainult direktiivide ja standardite erinevusest eri riikides, vaid oleneb ka suurel määral erinevustest vastavushindamises.

Kogu vastavushindamist saab jagada kaheks:

1. reguleeriv

2. vabatahtlik

Nende 2 ala poliitika määratlemisel on kokku lepitud kolme tasandi osas:

- määruste harmoniseerimine
- kokkulepped rahvuslike määruste vastuvõtmiseks
- vabatahtliku vastavushindamise ühtse struktuuri loomine

Kõik kokku peaks see viima EL raames ühekordsetele katsetustele.

Tehnilistele õigusaktidele vastavushindamine

Vastavalt New Approach'ile töötas Euroopa Liit sel alal välja poliitika, mis on kirja pandud Nõukogu resolutsioonis "A Global Approach to Conformity Assessment".

Euroopa Liidu riigid kiitsid selle heaks 1989 a lõpul.

Selle eesmärk on muuta olukorda, kus tootjad läbivad EL turul mitmekordse kontrolli - igal turul uuesti vastavalt selle riigi nõuetele.

Global Approach'i peamised elemendid:

- * Iga tootedirektiivi nõuete hulgas loetletakse tootja poolt täidetavad vastavushindamise kohustused ja protseduurid. Selleks on Global Approach'i raames kavandatud uus seadusandlik süsteem "Modular Approach". Viimane jagab vastavushindamise toote valmimisprotsessiga seotud

protseduurideks (nt disain, tootmine jne), hindamistüübiks (dokumentide kontroll, tüübikatsetused, kvaliteeditagamine, kontroll) ja määrab, kes juhib hindamist.

- * 2. tähtis element on notifitseeritud organite kaasamine kõikide moodulite testimisse ja sertifitseerimisse. See põhineb EL liikmete põhimõttelisel vastutusel kompetentsuse hindamise eest (tehniline akt) ja notifitseerimisel endal (poliitilis-halduslik akt). Notifitseeritud organid on need riigi katselaborid, kontroll- ja sertifitseerimisorganid, kus kompetentsushindamine on lõpule viidud ja mis on riigi valitsuse poolt nimetatud notifitseerivaks organiks. Kompetentsuse hindamiseks kasutatakse Euroopa standardeid (EN 45000 sari).

- * 3. element on tööstustoodetel CE märgi kasutamine. See märk näitab, et tootja on täitnud kõik EL direktiivides antud toote kohta esitatud nõuded.

- * Global Approach'i viimane peatükk "External Aspects" puudutab kauplemist väljaspool Euroopat asuvate partneritega. On arvatud, et EL ühtne katsetuste ja sertifitseerimise struktuur on aluseks suurema usalduse tekkimisele EL välistes riikides - seda kas mõlemapoolselt või osalemise kaudu rahvusvahelistes organisatsioonides. Juhtivaks põhimõtteks on EL sidumine GATT-iga, garanteerides EL toote vastavushindamise protseduuridele mittediskrimineeriva juurdepääsu väljaspool ühendust.

Vabatahtlik vastavushindamine

Lisaks määrustele peeti oluliseks luua ka vastav võrk reguleerimata sfääri jaoks. Aprillis 1993 loodigi selleks EL, EFTA, CEN'i, CENELEC'i algatusel Euroopa Katsetus- ja Sertifitseerimise

Organisatsioon EOTC. EOTC eesmärgiks on usalduse loomine kõigi vastavushindamise tulemustest huvitatud poolte vahel, lihtsustades sel moel tehnospetsifikaatidele vastavate kaupade ja teenuste vaba liikumist Euroopas.

Kõige tähtsamal kohal EOTC struktuuris on lepingu alusel töötavad rühmad, kes püüavad täita vähemalt ühte järgmistest ülesannetest:

- kalibreerimis- või katsetulemuste, kontrollprotokollide, toote sertifikaatide või kvaliteedisüsteemide vastastikune tunnustamine vastavalt EN-ISO 9000 sarja standarditele või
- kalibreerimis-, katsetus-, kontroll-, sertifitseerimis- ja/või akrediteerimisprotseduuride harmoniseerimine.

EOTC tegutseb kavatsuste kohaselt ka EL/EFTA tugiorganina.

CEN ja CENELEC aitavad kaasa EOTC eesmärkide saavutamisele.

Vastavalt turunõuetele on CEN koos oma liikmetega algatanud Euroopa Standardite Ühitamise Gruppide (European Standard Agreement Groups) loomise vastavushindamise tulemuste ja vastavusmärkide vastastikuseks tunnustamiseks. Need grupid on autonoomsed ja loodetavasti muutuvad nad tulevikus EOTC koostisosadeks.

Samal eesmärgil on CENELEC loonud osana oma struktuurist Euroopa Elektrotehnika katsetus- ja sertifitseerimiskomitee (ELSECOM).

CEN ja CENELEC (koos ELSECOM'iga) tegutsevad Euroopa toodete sertifitseerimisel, mis võivad kanda Euroopa kvaliteedimärki kõrvalt rahvuslike märkidega. Viimastele jääks arvestatav kohalik väärtus.

Lõppkokkuvõttes on ette näha, et Euroopa vastavusmärk, mis näitab toote vastavust Euroopa standardile, kinnitatakse CE märgi kõrvale osutamaks, et tootja on rahuldanud kõik kohustuslikud nõuded.

Rahvuslike standardiorganite tähtsus New Approach'i rahvuslikul kasutuselevõtul

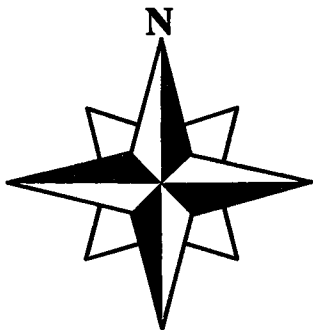
1985. aasta otsus esitada Euroopa turufilosoofia osana New Approach on toonud suuri muutusi rahvuslike standardiorganite tegevuses.

Enne 1985 aastat koostati standardeid nii rahvuslikul kui rahvusvahelisel tasandil. Sellest ajast on toimunud muutus standardite koostamise protsessis. Põhiraskus on nüüd rahvusvaheliste ja Euroopa standardite koostamisel. Rahvuslikke standardeid koostatakse ainult spetsiifiliste rahvuslike vajaduste korral.

See tähendab, et rahvuslike standardiorganite kaastöö või info on kas osa vastavatest rahvusvahelistest ning Euroopa struktuuridest või siis on tihedalt liitunud nende struktuuridega.

New Approach peaks kajastuma rahvuslike standardiorganite rollis ja vastutuses, võimaldamaks neil organitel täita oma rolli põhiliste kvaliteedi ühenduslülidena oma riigi - antud juhul Eesti, ja Lääne-Euroopa riikide vahel. See on tingimuseks, et Eesti standardikasutajaid õigesti ja õigeaegselt kaasata vabaturu-majandusse. Eriti käib see tööstuse, ministriumide ning toodetele ja süsteemidele orienteeritud vastavushindamise organite kohta Eestis.

EESTI SEADUSANDLUSE LÄHENDAMISEST EL SEADUSANDLUSELE



10 aprillil parafeeriti Eesti ja Euroopa Liidu vaheline assotsiatsioonileping. Selle lepinguga võtab Eesti endale kohustuse lähendada oma seadusandlust Euroopa Liidu seadusandlusele. Üheks esmajärjekorras lähendamist vajavaks valdkonnaks on tunnistanud tehnilised õigusaktid (Technical Regulations, directives). Teisisõnu peaksid õigusaktide sätted olema kajastatud Eesti õigusaktides (seadused, eri tasandite määrused jms). Eestis kehtestavad tooteid käsitlevad õigusaktid peaksid olema võimalikult kooskõlas Euroopa Liidu õigusaktidega.

Abistamiseks Euroopa Liiduga assotsiatsioonilepinguid ettevalmistavaid riike lepingu selle sätte täitmisel, korraldati PRAQ92 ekspertide poolt Stockholmis 10 - 12 aprillini seminar. Osalesid kõik PRAQ92-ga hõlmatud riigid - Albaania, Eesti, Leedu, Läti ja Sloveenia. Eesti kolmeliikmelisse delegatsiooni kuulusid Välisministeeriumi välismajanduspoliitika osakonna referent pr Sirje Sepp, Justiitsministeeriumi EL õiguse

osakonna juhataja hr Indrek Orav ja allakirjutanu.

Kolmel seminaripäeval tutvustati Euroopa ühisturu põhimõtteid ja EL õigusakte, pöörates erilist tähelepanu tehnilistele õigusaktidele, EL õigusaktide tõlkimise meetodikat, tõlkekeskuse loomist ja tegutsemist väikeriigis jpm.

Osavõtjatele jaotati ettekannete tekste ja teisi abimaterjale.

Loomulikult oli kõige väärtuslikumaks PRAQ92 ekspertide poolt ettevalmistatud dokumentide pakett, mis sisaldab valdkondade kaupa esmajärjekorras oma seadusandluse viimist vajavate EL tehniliste õigusaktide soovitava loetelu ning eesmärgi saavutamiseks vajalikud meetodid ja vahendid.

Piltlikult öeldes juhatati teotsale ja anti leivakott kaasa. Tee tuleb aga läbi käia meil endil, vajadusel täiendades ekspertide soovitusi.

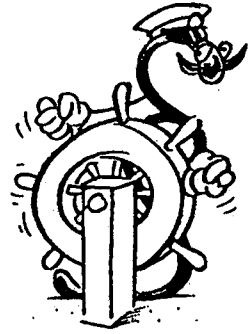

EUROOPA LIIDU TEHNILISED ÕIGUSAKTID

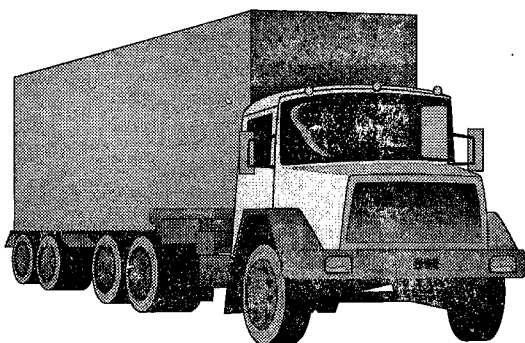

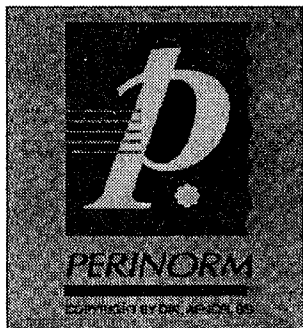

Euroopa Liidus on paljud tooted varustatud CE märgiga. CE märk tähendab, et antud toode vastab EL direktiivi nõuetele. CE märgistus käib ainult EL Uue lähenemisviisi

direktiivide kohta, mis käsitlevad põhiliselt mänguasjade, masinate, meditsiinitorodete ja gaasiseadmete ohutusnõudeid.

CE märki võib kasutada kas tootja enda kinnituse kohaselt või erapooletu nn kolmanda osapoole tunnistuse põhjal, et antud toode vastab antud direktiivi nõuetele. Millist moodust kasutada, seda näitab direktiiv.

Antud käsiraamat sisaldab 22 12 1994 Soomes kehtestatud CE märgi kasutamise seaduse.

Käsiraamatu lõpus on toodud Soomes registreeritud sertifitseerimisorganite nimekiri, Uue lähenemisviisi direktiivide loetelu, SFS vorm Direktiivi nõuetele vastavuse kinnitamise kohta.

Standardiameti poolt on välja antud **esimesed 7 Eesti standarditeks ülevõetud ISO standardit**, mis sisaldavad ISO standardite **ekvivalentse eestikeelse tõlke** ja nende ingliskeelse teksti.

Kvaliteedijuhtimise ja -tagamise küsimuste suhtelise uudsuse tõttu puudub eesti keeles väljakujunenud terminoloogia, mille tõttu eestikeelsete standardite ettevalmistamine võttis plaanitud rohkem aega.

Need Eesti standardid on enamuses üle võetud ISO standardite varasemate versioonide alusel (va ISO 9004-2). Eesti standardite ilmumise ajaks on välja antud ISO standardite ISO 8402, ISO 9000, ISO 9001, ISO 9002, ISO 9003 ja ISO 9004 uustöötlusted. Uustöötlustes on tehtud väiksemaid muudatusi ja parandatud materjali esitamiseviisi. Kuna suuri põhimõttelisi erinevusi varasema ja uue versiooni vahel ei ole, on väljaantud Eesti standardid suureks abiks ISO 9000 ideoloogia mõistmisel ja ISO 9000-järgse kvaliteedisüsteemi juurutamiseks ettevalmistamisel.

Suuremate muudatustega ISO uustöötlusted peaksid ilmuma plaani järgi 1996 aastal. ISO 9000-1, mis on praegu ettevalmistamisel ülevõtuks Eesti standardiks, toob ära uustöötluste I etapi suuremad muudatused.

1994 aastal ilmunud ISO 9000 põhistandardite uued versioonid on ettevalmistamisel ülevõtmiseks Eesti standarditeks. Nende ilmumine on kavandatud 1996 aastal.
