This document specifies a test method for the qualification and quantification of organotin compounds. This test method is applicable to all types of materials of textile products.

4 Principle

The organotin compounds are extracted from the material of a textile product with a methanolethanol mixture using tropolone as a complexing agent. The mono- and di-organotin-tropolone complexes and tri-organotin cations formed in the extraction procedure are directly analysed by a liquid chromatograph with a tandem mass spectrometer (LC-MS/MS). This method does not require additional derivatization step.

<u>Table 1</u> indicates the list of organotin compounds which can be analysed with this document.

This document is also applicable for further organotin compounds provided that the method is validated with the additional compounds.
