This document specifies the technical requirements and test procedures for penetrant materials for their type testing and batch testing. This document covers the temperature range from $10\,^{\circ}\text{C}$ to $50\,^{\circ}\text{C}$. Additional tests in ISO 3452-5 or ISO 3452-6 can be required outside this range.

On-site control tests and methods are detailed in ISO 3452-1.
