1 Scope

This document specifies two separate methods for determining the resistance of a material to wet and dry abrasion.

It is applicable to the coated surface or surfaces of coated fabrics.

It does not apply to determining the abrasion behaviour of an uncoated surface of a coated fabric, for which the methods for uncoated textiles described in the ISO 12947 series apply.

4 Principle

This document details two different methods. In method 1, test specimens are clamped in a specimen holder and abraded using pieces of a selected abradant under constant pressure. A variant of this method consists of carrying out the method with a wet abradant. Method 2 reverses the position of the abradant and the specimen. In both cases, the relative movement between the abradant and the specimens creates a harmonic motion in right angles to each other by a cyclic planar motion in
