Terms and definitions

For the purposes of this document, the terms and definitions given in ISO 1968 apply.

Designation

Fibre ropes shall be designated by:

- the words "fibre rope";
- the number of this International Standard;
- the construction type of rope (see Clause 5);
- the reference number of the rope;
- the material from which the rope is made;
- the type of stabilization (1 or 2 in accordance with ISO 9554

Polyester laid ropes that are required to have a heat setting on the rope to ensure lay and dimensional stability are designated type 1 ropes; in other cases, polyester laid ropes that are not required to have a heat setting TO ON THE STATE OF on the rope are designated type 2 ropes.
