#### **Design and dimensions**

#### 4.1 General

General requirements for dental tweezers are specified in 190 15098-1.

College type dental tweezers shall have the designs shown in Figures 1 and 2 and the dimensions as given in Table 1. The points of measurement associated with the dimensions are listed in Table 2.

Annex A of ISO 15098-1:1999 provides details of one method of measurement applicable to most types of dental tweezers.

g to College type dental tweezers are grouped into the following types according to the shape of the working end:

- type 1: angled;
- type 2: curved.
