#### 3.1

#### degree of flaking

rating characterizing flaked areas in a coating in terms of quantity, size and depth

#### 4 Assessment

Assess the quantity of flaking by reference to Table 1 and using as an example Figure 1 or 2, depending on the type of flaking.

NOTE Figure 1 shows flaking without preferential direction and Figure 2 shows flaking in one preferential direction due to anisotropy of the substrate.
