## Foreword

International Standard

ISO 8367-2:1993 Packaging – Dimensional tolerances for general purpose sacks – Sacks made from thermoplastic flexible film,

which was prepared by ISO/TC 122 'Packaging' of the International Organization for Standardization, has been adopted by Technical Committee CEN/TC 261 'Packaging' as a European Standard.

This European Standard shall be given the status of a national standard, either by publication of an identical text or by endorsement, and conflicting national standards withdrawn, by February 1997 at the latest.

In accordance with the CEN/CENELEC Internal Regulations, the following countries are bound to implement this European Standard:

Austria, Belgium, Denmark, Finland, France, Germany, Greece, Iceland, Ireland, Italy, Luxembourg, Netherlands, Norway, Portugal, Spain, Sweden, Switzerland, and the United Kingdom.

## Endorsement notice

The text of the International Standard ISO 8367-2:1993 was approved by CEN as a European Standard without any modification.

## 1 Scope

This part of ISO 8367 specifies a set of tolerances applicable to the manufacture of sacks made from thermoplastic flexible film as defined in ISO 6590-2.

## 2 Normative references

The following standards contain provisions which, through reference in this text, constitute provisions of this part of ISO 8367. At the time of publication, the editions indicated were valid. All standards are subject to revision, and parties to agreements based on this part of ISO 8367 are encouraged to investigate the possibility of applying the most recent editions of the standards indicated below. ISO 6591-2:1985, *Packaging — Sacks — Description and method of measurement — Part 2: Empty sacks made from thermoplastic flexible film*.

ISO 7023:1983, *Packaging — Sacks — Method of sampling empty sacks for testing*.

## 3 Tolerances

Sacks to be measured shall be sampled in accordance with ISO 7023.

The thickness of the plies shall be measured in accordance with ISO 4593.

The dimensions shall be described and measured in accordance with ISO 6591-2. The tolerances of the dimensions shall be within the limits specified in table 1.
