Introduction

ISO/IEC 24730-61 and ISO/IEC 24730-1 define an air interface and an application programming interface for Real Time Locating Systems (RTLS) devices used in asset management applications.

This International Standard provides test methods for measuring performance of equipment compliant with ISO/IEC 24730-61.

ISO/IEC 24769-61 contains all measurements required to be made on a product in order to establish whether it conforms to the corresponding part of ISO/IEC 24730.

1 Scope

This International Standard defines the test methods for determining the performance characteristics of Ultra Wide Band (UWB) real time locating system (RTLS) equipment including tags and readers which are applicable to the selection of equipment that conforms to ISO/IEC 24730-6 for specific applications. This International Standard does not apply to the testing in relation to regulatory or similar requirements.

The RTLS equipment performance parameters included in this International Standard only include the Ultra Wide Band (UWB) radio frequencies link between tags and readers. Unless otherwise specified, the tests in this International Standard apply exclusively to RTLS equipment defined in ISO/IEC 24730-6.
