Foreword

This European Standard has been prepared by Technical Committee CEN/TC 192 "Fire service equipment", the secretariat of which is held by BSI.

This European Standard shall be given the status of a national standard, either by publication of an identical text or by endorsement, at the latest by July 1998, and conflicting national standards shall be withdrawn at the latest by July 1998.

EN 1846 consists of the following parts, under the general title "Firefighting and rescue service vehicles" :

- Part 1 : Nomenclature and designation,
- Part 2 : Common requirements - Safety and performance,
- Part 3 : Permanently installed equipment - Safety and performance requirements.

According to the CEN/CENELEC Internal Regulations, the national standards organizations of the following countries are bound to implement this European Standard: Austria, Belgium, Czech Republic, Denmark, Finland, France, Germany, Greece, Iceland, Ireland, Italy, Luxembourg, Netherlands, Norway, Portugal, Spain, Sweden, Switzerland and the United Kingdom.

Introduction

This part of the EN 1846 has been prepared in order to define a common designation system of firefighting and rescue service vehicles.

It also identifies the main characteristics of any motor vehicle by a serial number and letter as defined in the following clauses which may be used in invitations to tender within Europe.

1 Scope

This part of EN 1846 applies to firefighting and rescue service vehicles.

It establishes classes and defines categories which are functions of the use and mass of the vehicles.

A designation system gives the various criteria used for characterizing the vehicles.

2 Normative references

This European Standard incorporates by dated or undated reference, provisions from other publications. These normative references are cited at the appropriate places in the text and the publications are listed hereafter. For dated references, subsequent amendments to or revisions of any of these publications apply to this European Standard only when incorporated in it by amendment or revision. For undated references the latest edition of the publication referred to applies.
