1 Scope

This document sets out recommendations designed to maintain rubber and plastics hoses and hose assemblies, prior to use, in a condition as close as possible to the condition they were in when they were received and to obtain the expected service life.

NOTE It is intended that this document be used in conjunction with any applicable national statutory regulations.

4 General recommendations

4.1 Selection criteria

It is in the best interests of the user to select hoses or hose assemblies complying with national or international standards whenever such standards exist for the intended application. For applications outside the scope of such standards, needing special requirements or for which the necessary information is not available, the hose manufacturer or trade association should be consulted.

The following points should be taken into consideration when selecting a hose or hose assembly for a specific application:

- a) Operational environment:
 - ambient temperature;
 - atmospheric conditions;
 - contact with chemically aggressive liquids;
