Introduction

Vulcanized rubber held under a constant stress will contract as the test temperature is raised, while a test piece held under a constant strain will develop an increased stress. These are features of the Gough-Joule effect in rubber and, unless they are taken into account at the design stage, any resulting d o atures. scribes a te. in test tempe. changes in forces and dimensions can affect the performance of some products, such as rotary seals, used at high temperatures and high strains (see Reference [1]).

This document describes a test method for the determination of the change in tensile stress that results from an increase in test temperature.

This document specifies a method for measuring the stress in tension which is developed in vulcanized rubber when it is heated (thermal stress). The thermal stress is measured for various pre-strain and temperature conditions as a function of time.
