Foreword

The text of the International Standard IEC 60335-2-16:2002 (61/2278/FDIS) prepared by the IEC Technical Committee 61, Safety of household and similar electrical appliances, together with the common modifications prepared by CENELEC TC 61, was submitted to the Unique Acceptance Procedure and was approved by CENELEC as EN 60335-2-16 on 2003-07-01.

This European Standard replaces EN 60335-2-16:1996.

The following dates are applicable:

- date on which the national standards conflicting
with the EN have to be withdrawn (dow) 2006-07-01

This part 2 has to be used in conjunction with EN 60335-1, Household and similar electrical appliances - Safety - Part 1: General requirements. It was established on the basis of the 2002 edition of that standard. Amendments and revisions of Part 1 have also to be taken into account and the dates when such changes become applicable will be stated in the relevant amendment or revision of Part 1.

This part 2 supplements or modifies the corresponding clauses of EN 60335-1, so as to convert it into the European Standard: Safety requirements for electric food waste disposers.

When a particular subclause of Part 1 is not mentioned in this part 2, that subclause applies as far as is reasonable. When this standard states "addition", "modification" or "replacement", the relevant text of Part 1 is to be adapted accordingly.

NOTE 1 The following numbering system is used:

- subclauses, tables and figures that are numbered starting from 101 are additional to those in Part 1;
- unless notes are in a new subclause or involve notes in Part 1, they are numbered starting from 101, including those in a replaced clause or subclause;

Introduction

p Add:

An investigation by CENELEC TC 61 has shown that all risks from products within the scope of this standard are fully covered by the Low Voltage Directive, 73/23/EEC. For products having mechanical moving parts, a risk assessment in accordance with the Machinery Directive, 98/37/EC, has shown that the risks are mainly of electrical origin and consequently this directive is not applicable. However, the relevant essential safety requirements of the Machinery Directive are covered by this standard together with the principal objectives of the Low Voltage Directive.

FOREWORD

INTRODUCTION

It has been assumed in the drafting of this International Standard that the execution of its provisions is entrusted to appropriately qualified and experienced persons.

This standard recognizes the internationally accepted level of protection against hazards such as electrical, mechanical, thermal, fire and radiation of appliances when operated as in normal use taking into account the manufacturer's instructions. It also covers abnormal situations that can be expected in practice.

This standard takes into account the requirements of IEC 60364 as far as possible so that there is compatibility with the wiring rules when the appliance is connected to the supply mains. However, national wiring rules may differ.

If an appliance within the scope of this standard also incorporates functions that are covered by another part 2 of IEC 60335, the relevant part 2 is applied to each function separately, as far as is reasonable. If applicable, the influence of one function on the other is taken into account.

This standard is a product family standard dealing with the safety of appliances and takes precedence over horizontal and generic standards covering the same subject.

An appliance that complies with the text of this standard will not necessarily be considered to comply with the safety principles of the standard if, when examined and tested, it is found to have other features that impair the level of safety covered by these requirements.

An appliance employing materials or having forms of construction differing from those detailed in the requirements of this standard may be examined and tested according to the intent of the requirements and, if found to be substantially equivalent, may be considered to comply with the standard.

HOUSEHOLD AND SIMILAR ELECTRICAL APPLIANCES – SAFETY –

Part 2-16: Particular requirements for food waste disposers

1 Scope

This clause of Part 1 is replaced by the following.

This International Standard deals with the safety of electric **food waste disposers** for household and similar purposes, their **rated voltage** being not more than 250 V.

Appliances not intended for normal household use but that nevertheless may be a source of danger to the public, such as appliances intended to be used by laymen in shops, in light industry and on farms, are within the scope of this standard.

As far as is practicable, this standard deals with the common hazards presented by appliances that are encountered by all persons in and around the home. However, in general, it does not take into account

- the use of appliances by young children or infirm persons without supervision;
- playing with the appliance by young children.

NOTE 101 Attention is drawn to the fact that

- for appliances intended to be used in vehicles or on board ships or aircraft, additional requirements may be necessary;
- in many countries additional requirements are specified by the national health authorities, the national authorities responsible for the protection of labour, the national water supply authorities, and similar authorities;
- the installation of **food waste disposers** may be restricted or not allowed.

NOTE 102 This standard does not apply to

- portable **food waste disposers**;
- **food waste disposers** of the incinerator type;
- appliances intended exclusively for industrial or commercial purposes;
- appliances intended to be used in locations where special conditions prevail, such as the presence of a corrosive or explosive atmosphere (dust, vapour or gas).

2 Normative references

This clause of Part 1 is applicable.

3 Definitions

This clause of Part 1 is applicable except as follows.

3.1.9 Replacement:

normal operation

operation of the appliance under the following conditions

The hopper is filled with 30 cubes of soft pinewood, the side of each cube having a length of $12 \text{ mm} \pm 2 \text{ mm}$. The appliance is operated with water having a temperature between $10 \text{ }^{\circ}\text{C}$ and $24 \text{ }^{\circ}\text{C}$ flowing through the appliance at a rate of 8 l/min. If the hopper cannot contain all the cubes at the same time, they are added as quickly as possible during the operation of the appliance.
