Foreword

The text of the International Standard IEC 60335-2-31:2002 (61/2206/FDIS) prepared by the IEC Technical Committee 61, Safety of household and similar electrical appliances, was submitted to the Unique Acceptance Procedure and was approved by CENELEC as EN 60335-2-31 on 2003-05-01.

This European Standard replaces EN 60335-2-31:1997 + corrigendum October 1997 + A1:1999.

The following dates are applicable:

- latest date by which the EN has to be implemented
at national level by publication of an identical
national standard or by endorsement (dop) 2004-05-01
- date on which the national standards conflicting
with the EN have to be withdrawn (dow) 2006-05-01

This part 2 has to be used in conjunction with EN 60335-1, Household and similar electrical appliances - Safety - Part 1: General requirements. It was established on the basis of the 2002 edition of that standard. Amendments and revisions of Part 1 have also to be taken into account and the dates when such changes become applicable will be stated in the relevant amendment or revision of Part 1.

This part 2 supplements or modifies the corresponding clauses of EN 60335-1, so as to convert it into the European Standard: Safety requirements for electric range hoods.

When a particular subclause of Part 1 is not mentioned in this part 2, that subclause applies as far as is reasonable. When this standard states "addition", "modification" or "replacement", the relevant text of Part 1 is to be adapted accordingly.

NOTE 1 The following numbering system is used:

- subclauses, tables and figures that are numbered starting from 101 are additional to those in Part 1;
- unless notes are in a new subclause or involve notes in Part 1, they are numbered starting from 101, including those in a replaced clause or subclause;
- additional annexes are lettered AA, BB, etc.;
- subclauses, notes and annexes that are additional to those in the IEC standard are prefixed with the letter Z.

NOTE 2 The following print types are used:

- requirements: in roman type;
- *test specifications: in italic type*;
- notes: in small roman type.

Words in **bold** in the text are defined in Clause 3. When a definition concerns an adjective, the adjective and the associated noun are also in bold.

There are no special national conditions causing a deviation from this European Standard, other than those listed in Annex ZA to EN 60335-1.

National deviations from this European Standard are listed in Annex ZB and are in addition to those in EN 60335-1.

Introduction

p Add:

An investigation by CENELEC TC 61 has shown that all risks from products within the scope of this standard are fully covered by the Low Voltage Directive, 73/23/EEC. For products having mechanical moving parts, a risk assessment in accordance with the Machinery Directive, 98/37/EC, has shown that the risks are mainly of electrical origin and consequently this directive is not applicable. However, the relevant essential safety requirements of the Machinery Directive are covered by this standard together with the principal objectives of the Low Voltage Directive.

The instruction sheet of range hoods of the exhaust-air type shall include the substance of the following warning:

Bei gleichzeitigem Betrieb der Dunstabzugshaube im Abluftbetrieb und Feuerstätten darf im Aufstellraum der Feuerstätte der Unterdruck nicht größer als 4 Pa (4×10^{-5} bar) sein.

When the range hood and appliances supplied with energy other than electricity are simultaneously in operation, the negative pressure in the room must not exceed 4 Pa (4×10^{-5} bar).

Range hoods shall be constructed so that parts likely to accumulate deposits of grease and the like can be effectively cleaned. It is assumed that even parts located behind a filter, including the fan, are likely to accumulate grease and the like. This means that it shall be possible to gain access to the parts concerned.

FOREWORD

The following differences exist in the countries indicated below.

- 7.12: Warnings are required to be marked on the range hood (USA).
- 7.12.1: Additional requirements are specified for range hoods intended to be placed above gas hobs (Sweden).
- 8.2: The insulation of internal wiring need not be equivalent to IEC 60227 or IEC 60245 (USA).
- 11.2: The test method is different (USA).
- 19.101: The test method is different (USA).
- 20.2: The addition applies only to disposable filters (USA).
- 22.101: Additional fixing means are not required if screws can be tightened in keyhole slots (USA).
- 22.102: Parts located behind a filter are considered to be parts that have to be cleaned (Sweden).
- 30.101: The method of evaluating filters is different (USA).

A bilingual version of this standard may be issued at a later date.

INTRODUCTION

It has been assumed in the drafting of this International Standard that the execution of its provisions is entrusted to appropriately qualified and experienced persons.

This standard recognizes the internationally accepted level of protection against hazards such as electrical, mechanical, thermal, fire and radiation of appliances when operated as in normal use taking into account the manufacturer's instructions. It also covers abnormal situations that can be expected in practice.

This standard takes into account the requirements of IEC 60364 as far as possible so that there is compatibility with the wiring rules when the appliance is connected to the supply mains. However, national wiring rules may differ.

If an appliance within the scope of this standard also incorporates functions that are covered by another part 2 of IEC 60335, the relevant part 2 is applied to each function separately, as far as is reasonable. If applicable, the influence of one function on the other is taken into account.

This standard is a product family standard dealing with the safety of appliances and takes precedence over horizontal and generic standards covering the same subject.

An appliance that complies with the text of this standard will not necessarily be considered to comply with the safety principles of the standard if, when examined and tested, it is found to have other features that impair the level of safety covered by these requirements.

An appliance employing materials or having forms of construction differing from those detailed in the requirements of this standard may be examined and tested according to the intent of the requirements and, if found to be substantially equivalent, may be considered to comply with the standard.

HOUSEHOLD AND SIMILAR ELECTRICAL APPLIANCES – SAFETY –

Part 2-31: Particular requirements for range hoods

1 Scope

This clause of Part 1 is replaced by the following.

This International Standard deals with the safety of electric **range hoods** intended for installing above household cooking ranges, hobs and similar cooking appliances, their **rated voltage** being not more than 250 V.

NOTE 101 The cooking appliance may be supplied by electricity or other fuels, such as gas.

Appliances not intended for normal household use but that nevertheless may be a source of danger to the public, such as appliances intended to be used by laymen in shops, in light industry and on farms, are within the scope of this standard.

As far as is practicable, this standard deals with the common hazards presented by appliances that are encountered by all persons in and around the home. However, in general, it does not take into account

- the use of appliances by young children or infirm persons without supervision;
- playing with the appliance by young children.

NOTE 102 Attention is drawn to the fact that

- for appliances incorporating electrostatic air filters, IEC 60335-2-65 also applies;
- for appliances intended to be used in vehicles or on board ships or aircraft, additional requirements may be necessary;
- in many countries additional requirements are specified by the national health authorities, the national authorities responsible for the protection of labour, the national authorities responsible for buildings and similar authorities.

NOTE 103 This standard does not apply to

- appliances intended for commercial purposes (IEC 60335-2-99);
- appliances intended to be used in locations where special conditions prevail, such as the presence of a corrosive or explosive atmosphere (dust, vapour or gas).

2 Normative references

3 Definitions

This clause of Part 1 is applicable except as follows.

range hood

motor-operated appliance intended to collect contaminated air from above a hob

NOTE The filtered air may be discharged back into the room or ducted away.
