1 Scope

This European Standard specifies a test method to measure the adhesion of a resilient or textile floor covering or wall covering bonded to a given substrate under shear forces. The term "wall covering" does not include any type of wallpaper.

3 Terms and definitions

For the purposes of this document, the terms and definitions given in EN 923:2005+A1:2008 and the following apply.

3.1

covering

flexible resilient or textile floor covering or wall covering

3.2

adhesive for coverings

adhesive which is intended to produce firm and durable bonds between coverings and various substrates

4 Principle

The adhesion is determined by measuring the shear strength under specified conditions before and after storing the bonds at 23 °C/ 50 °C under specified conditions.
