INTRODUCTION

This document cancels and replaces method E7 of IEC 60794-1-21:2015, which will be withdrawn. It includes an editorial revision, based on the new structure and numbering system for optical fibre cable test methods. Additionally, technical changes were implemented. The mechanical tests contained in IEC 60794-1-21:2015 will be individually numbered in the IEC 60794-1-1xx series. Each test method is now considered to be an individual document rather than part of a multi-test method compendium. Full cross-reference details are given in IEC 60794-1-2.

1 Scope

This part of IEC 60794 applies to optical fibre cables for use with telecommunication equipment and devices employing similar techniques, and to cables having a combination of both optical fibres and electrical conductors.

This document defines test procedures used in establishing uniform requirements for torsion performance.

Refer to IEC 60794-1-2 for a reference guide to test methods and for general requirements and definitions.

NOTE Throughout this document, the wording "optical cable" also includes optical fibre units, microduct fibre units, etc.

4 Method E7 – Torsion

4.1 Object

This test method is intended to establish the ability of a fibre optic cable to withstand mechanical twisting. The primary purpose of this procedure is to measure any variation in the attenuation of a fibre when the cable is subjected to torsional forces external to the cable sheath. The secondary purpose is to evaluate the possibility of physical damage that can occur as a result of such stresses.

4.2 Sample

The sample of fibre optic cable shall be long enough to permit the appropriate clamping and twisting and be long enough to permit a change in attenuation measurements as required by the relevant specification.
